Terms & Conditions:

1. Tender documents can be collected from **BRDS Head office H#01 Killi kiazai kerkhasan Road Western bypass Quetta Ph#0812862230**, from **23-Sep-2019 9:00 am** till **02-Oct-2019 5:00 pm**, Monday to Friday.-. 2. Sealed tenders should reach **BRDS Head office at address given above** on or before **11:00 am on 03rd Oct-2019** and should be clearly marked "TENDER - Not to be opened before "11:30p.m on 03-Oct-2019"
3. Tenders will be opened on the same day **i.e. 03-Oct-2019 at 11:30 pm hrs** in the presence of suppliers or their representatives, who wish to witness the tender opening.
4. In case a public holiday is announced by the Government (Due to any reason), the tender will be opened the next working day at the same time and venue.
5. A pay order/ demand draft in favor of "BRDS" with a value of 5% of the bid amount must also accompany the bid as Tender Guarantee. Bids received without Tender Guarantee may be rejected. If the selected bidder refuses to sign the supplies contract then BRDS reserves the right to forfeit the bid security.
6. Samples will be asked from short listed suppliers. Samples need to be arranged on short notice (within a day or two as the case may be).
7. The Supplier must quote only one option for each item. Bids received with more than one options and rates may be rejected.
8. Bidders can apply for a single or multiple Lots. However for solar system specialist & experienced supplier will be given preference. BRDS reserves the right to divide the order Lot wise.
9. Tender committee reserves the right to change the quantities or cancel/reject any or all offers without assigning any reason.
10. Suppliers must not be engaged in any corrupt, fraudulent, collusive or coercive practices including but not limited to applying/ bidding by multiple names / companies. If any bidder is found to be involved in such practices his/her bid may be rejected and the companies in question permanently black listed
11. Lowest price will not be the sole criteria; quality, delivery time and previous experience will also be considered.
